Self advocates would like to choose how they receive updates from providers – text, phone, email.

Rota is sent but can change quite quickly and have to change plans

Popular ideas were having client account access for staff and using verbal passwords



We Did

We can feed this back to providers – this might be something the Communications Group pick up

Provider said it is sad to hear you change your activity to fit the carer you get. Care should be about you and getting the support you need

Password sounds like a really good idea

Jolly holidays is something you've seen on facebook where a team support people to go to places like Alaska

With annual reviews you should have who you want there and not be asked to meet without your family

You asked for provider feedback on what they do if you carer is going to change that day



We Did

This experience has been fed back

JN fed back there are 3 main providers
Purple Oak, You Trust and J&K

This is the feedback:

- J&K - All are made aware of a change in advance and as soon as possible. Someone new may just turn up if have been unable to contact the person receiving the visit on phone eg if the phone wasn't picked up
- YouTrust – No formal policy –Usually match individual people to what staff/needs prefer. Will honour a visit rather than cancel. Has a smaller team who shadow each other, rare that someone completely new has to turn up
- Purple Oak - A group of people work with each individual – rare for someone unknown or agency to be used.
- Good to hear what people receive, customer service and ideas to feel safer
- You can speak to a provider if you are not happy with a service maybe with an advocate

JN reminded everyone about the consultation

You raised an issue about someone being left by carer outside a pub whilst they went home to get a jacket, you said the person wants to resolve it in house but you wanted to raise it

You raised concerns about not having the same social worker

If HCC pay for this care and you're not happy with provider response you should tell HCC

Social workers are provided for a short time for set piece of work due to amount of support needed in Hampshire

Hampshire County Council Future Services Consultation

Hampshire County Council is asking for people's views on the future of some local services in a public consultation on options to help the Authority meet a £132 million budget shortfall by April 2025

She told us how important it is to fill it in and to tell other people, like friends and family in Hampshire to fill it in too

The charging proposal affects those who pay towards their care and they will have had a letter in Easy Read

This affects everybody which might be why

You gave more ideas to tell the Dome and Friday Network

You said 'having services is important to us'

You said 'disabled people get hit the most, more than the rich'

You said 'whatever you do it will affect people'

You asked if the survey is available in braille

Nicky asked where else could we tell people about it?

Nicky said of the 13 proposals it is important to fill in what matters to you, like:

Passenger Transport, grants for small, local groups and costs for care.

Tell people to do the survey

You said the buddy scheme is important and that sometimes the hours given in care aren't enough to plan activities for meaningful support

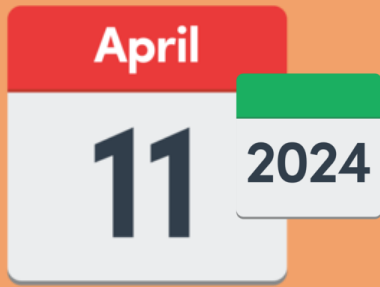

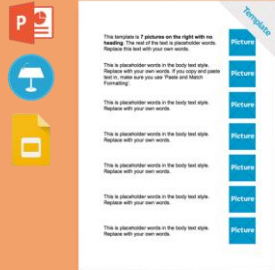

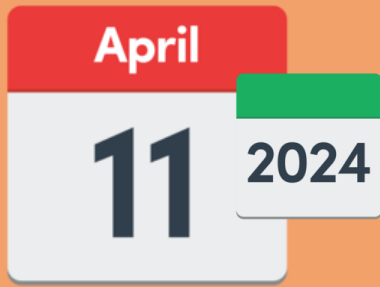


Adult Social Care Working Group You Said, We Did

- **We shared** some examples of different types on them





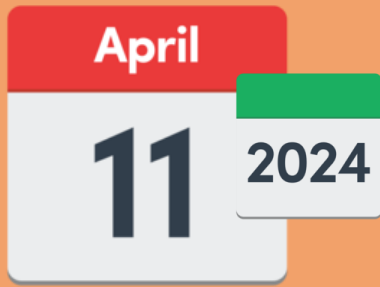

- **We looked** at some information on websites like Mencap and our own website



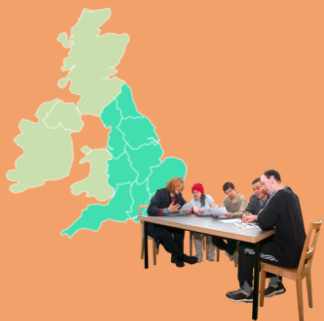
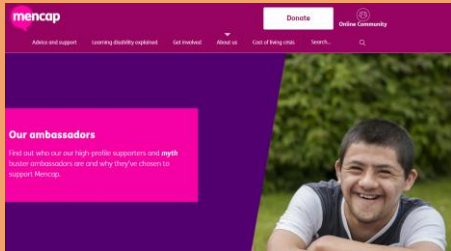

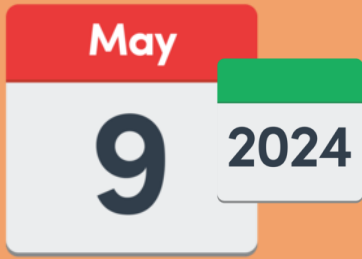
- **You said** you think this is an important topic and people need to know where to get help

- **You said** you would be interested to meet self-advocates from other Learning Disability Partnerships





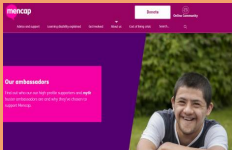

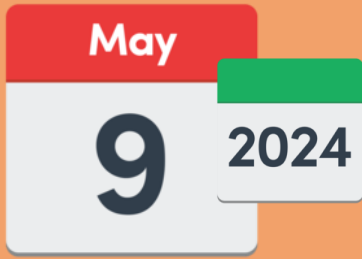

- **We said** to link with Primary Care Network about health checks



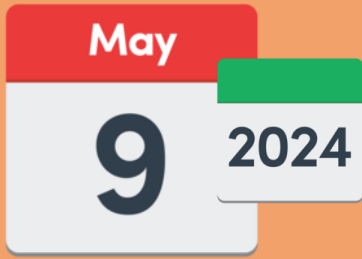

- **You** Marcia, Katie and James spoke to everyone to share ideas of what good support should look like



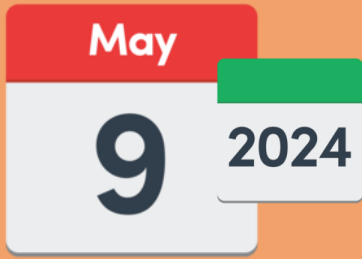


Adult Social Care Working Group You Said, We Did

- **You said** some groups give you a paper timetable which helps





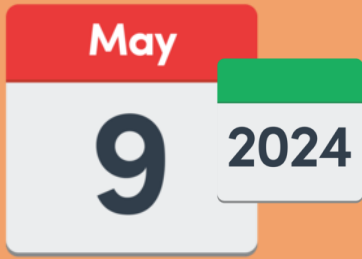

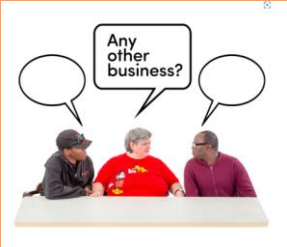
- **We talked** about using online maps and what is needed to help
