Ann Barker updated on the Complex Needs Group:

Looking for an independent advocate to chair. Amanda received one response saying they didn't have that level of knowledge/experience. Shows it is an overlooked area in LD services. Stuart said this was disappointing and will speak with Steve on next steps to find a chair.

Have discussed funding for therapies and health need/benefit to access ICB funding. Discussed staff training and agency use. Providers regulated by CQC staff have 12 week training and competency assessed, not same for agencies. In current climate how to keep high standards when lack of workforce.

Stuart has commissioned workforce review with NHS to look at solutions for the workforce challenge in Hampshire, add to national debate on future solutions to be louder.
