Self-Advocates of the HLDP gave an update on the working groups - presentation attached

Discussion:

A parent carer said they were amazed by how busy self-advocates have been and how many people they have met and talked to. They asked if people feel heard and listened to.

Self Advocates said – 50/50 that we are listened to. Easy Read helps. Felt listened to about OM training and Meals on Wheels poster feedback. Easier when its face to face.

Enjoyed making videos at the Dome, when people come back feel listened to. Like CART changes we want and felt listened to. Important to be honest if you can/can't make changes.

Interesting to know what you've done, and important to know it made a change. An easy word isn't less valuable, simpler language is the best.



Break

Carers Group Update for the HLDP RS sent his apologies, due to stand in for DH. AL shared some carer updates

AB shared that she attends a local carers meeting once a month, but not the carers group with Partnership, attending Complex Needs instead.

There is less respite care for younger people and big changes in housing and looking at what has worked well in the past. Making sure people not afraid to give feedback.
